

# Park Use Regulations

The following is a list of Park regulations for Neale Peterson Park, Kathryn Lyon Flora Park and all parkland/green spaces within Fairway City Limits. While this list is not all-inclusive, it is meant to serve as a guide to Park usage. - 1. Décor** - No decorations shall be displayed, installed or provided that may damage or deface Park grounds or facilities. Use of staples or nails, etc. is not allowed on trees, poles or painted surfaces.
- 2. Solicitation** - No soliciting of any kind shall be permitted on city Park grounds or facilities.
- 3. Hours of Operation** – Parks are considered open during the following times: 8:00 a.m. to 10:00 p.m. from April 15th thru Sept. 15th and 8:00 a.m. to sunset from Sept. 16th thru April 14th per city ordinance 11-112. No person shall enter or remain in the Parks outside the established hours unless he/she is participating in a Parks & Recreation Department program or with written permission from the Parks & Recreation Director.
- 4. Vehicles** - No vehicle may be brought onto unpaved Park grounds for any purpose, including, unloading, loading, etc per City ordinance 11-102. Exception: City employees acting within the bounds of their duties and delivery vehicles may drive up to buildings or shelters as necessity dictates.
- 5. Alcohol** - No alcoholic beverage of any type is allowed on City property per ordinance 11-110. No person shall enter or be in Parks while under the influence of alcohol. Any violations will be reported to the Fairway Police Department.
- 6. Disorderly Conduct** – The following constitutes disorderly: drunkenness, vile language, fighting and personal exposure. These acts of personal conduct are not allowed per city ordinance 11-109.
- 7. Trash/Refuse** - Each person/group is responsible for cleaning up his/her/their own area. All refuse must be placed in the provided receptacles per City ordinance 11-108.
- 8. Personal Property/Yard Waste/Large Items** - No person shall deposit any refuse brought from private property in receptacles located at a City Park. Exception: The Public Works Department will periodically collect such items during the year. During these times, all waste must be placed in the large dumpsters located in the swimming pool parking lot. Fairway citizens will be made aware of these times through the quarterly newsletter and other forms of media deemed appropriate.
- 9. Sale of Goods and Services** – No person shall sell or advertise for the sale of goods or services on Park property without written permission from the Parks & Recreation Director. Further, no food, game, or vendor booth or vehicle may be erected or placed on Park property without prior approval from the City Council per City ordinance 11-111.
- 10. Inflatables** - Moon walks and/or any type of inflatable are allowed ONLY if the providing company has proper insurance on file with the City and written permission from the Parks & Recreation Director or his/her designee.
- 11. Animals (Non-domestic)** - Pony rides, petting zoos, or any other activity where non-domesticated animals are present are prohibited without prior written approval from the Parks & Recreation Director.

**12. Animals (Domestic)- All domesticated animals must be on a leash and under immediate control of the owner per City ordinance 11-103.**

**13. Fireworks - Fireworks of any kind are prohibited per City ordinance 11-104.**

**14. City Property - Removing, damaging, defacing, and/or altering any structure, tree, fence, landscaping or property of the City is prohibited per City ordinance 11-107.**

**15. Noise - No amplification of band instruments, music or public address (PA) equipment allowed without prior written approval from the Parks & Recreation Director.**

**16. Grills - Only the two outside cooking devices provided at Neale Peterson Park are allowed on Parks grounds unless otherwise specified in writing by the Parks & Recreation Director.**

**17. Signs - No sign of any kind may be posted or affixed to any structure, utility pole, fence or tree per City ordinance 11-106.**

**18. Dangerous Devices – No person, except for law enforcement officials, shall have in his/her possession on Park grounds any firearm, air gun, slingshot, bow and arrow, crossbow, sword, knife, BB gun, dart device, boomerang or any other form of weapons that are potentially dangerous to human and animal safety.**

**19. Fires – No person shall build or use a fire unless done so in the provided grills for cooking purposes only, per City ordinance 11-105.**

**20. Climbing Trees, Monuments, etc. – No person shall climb any tree or walk, stand or sit upon monuments, fountains, railings, fences or upon any other property not designated or customarily used for such purposes.**

**Any person convicted of violating City ordinances pertaining to public property shall, upon conviction thereof, be punished by a fine of up to five hundred dollars (\$500) per violation per City ordinance 11-114.**
