



## 2019 CITIZEN SATISFACTION SURVEY RESULTS

More than a decade has passed since the City of Fairway conducted an official survey to gauge levels of citizen satisfaction and perceived quality of life among its residents. A lot has happened in that decade too. Three individuals held the reins as Mayor, the swimming pool underwent a major renovation, Public Works relocated to a new facility and last, but certainly not least, City Hall moved... twice. As elected officials and staff work to identify challenges for the next decade, hearing residents' concerns about the current and future vision of the City is extremely important.


About the Survey respondents:

- 20% have lived in Fairway for 31+ years
- 22% have lived in Fairway for less than 5 years
- 93% own their home, 7% rent
- 96% plan to live in Fairway for the next 5 years
- 22% are over the age of 65
- 17% are under the age of 35
- 51% were female respondents, 49% male
- Respondents by Ward – Ward 1 (25%), Ward 2 (23%), Ward 3 (30%), Ward 4 (23%)



The results will likely not surprise many people that an overwhelming majority (96%) of survey participants were satisfied with their overall quality of life in Fairway. Ninety-five percent were satisfied with both the overall image of the City as well as with their feeling of safety in Fairway. In fact, Fairway rated above the national average and above the Kansas and Missouri regional average in all 49 areas that were assessed. The City rated significantly higher (6% or more) in 48 of these areas.

The survey was also an opportunity to determine if resident opinions on a few old topics have changed or remained the same over the years. One area the City often receives inquiries about is the southeast corner of Shawnee Mission Parkway and Mission Road. More than a decade ago the City looked at developing the site with a new City Hall and perhaps other business retail establishments. Feedback at the time indicated residents were not interested in the City developing the area. The latest survey shows that sentiment has not changed with 65% of respondents indicating the corner should be greenspace. *From the Mayor's Desk*



**WINTER IS COMING!** No, I have not lost my mind. The importance of that comment is one of the subject matters of my letter and one of the highlighted articles of this newsletter. Please take the time to read the article concerning Private Tree Trimming and my comments on KCP&L below. Among other things, I would like to update you concerning the ongoing work with KCP&L and the results of the Citizen survey. First of all, I would like to welcome our new Police Officers - Kyle Barker, Victor Buitrago, David Wheat and Scott Haesemeyer. Welcome to our City! We are so pleased that you have joined our Police Department.

The 2020 budget and 5-year Capital Improvement Plan have been completed. The City's financial position remains strong. Despite two major spring storms, we have made good progress on increasing our reserves as directed by the Finance Committee. Both the multiple winter snows and the spring storms provide added incentive to build the reserves to a more prudent level. We were able to maintain the mill levy at the same level as 2019.

**KCP&L** - After multiple emails, meetings and conversations with KCP&L, I am happy to report some progress toward resolving our power outage issues. A plan is being put together to address our reliability concerns. Starting in August, three of the major circuits into Fairway will be inspected to identify areas of concern that are or could create an outage. KCP&L will then develop a plan to improve those issues found. **IMPORTANT**, also, is the role residents play in managing tree growth on our private property. It is crucial that trees, especially around power lines, be trimmed on a regular basis. Not only is it good for the health of the tree but it is also the neighborly thing to do so your trees are not the cause of an outage. This newsletter includes information on private tree trimming. Please read it.

**SURVEY COMMENTS** - Thank you to all who responded to our Citizen survey. It is very important that we hear from residents as this is your City. Detailed results are included in this newsletter. I would like to address the open-ended comments received. There were many so, due to space, I will use this and future letters to respond.

- \* Bulk item trash pick-up - Allows 2 no charge bulk items (furniture) per month. Call WCA 816-380-5595 or visit [wca.waste.com/fairway](http://wca.waste.com/fairway) to schedule a pick-up for the 1st or 3rd Monday each month. It may take a few days for pick up to occur with the separate bulk item collection truck.
- \* The islands are maintained by the various Homes Associations, not the City.
- \* The City budgets to maintain 1/3 of the right-of-way trees each year.
- \* An updated and improved website has been budgeted for 2020.
- \* Timely communication is available through City Email Program. Please sign up!
- \* Residents' contributions are always welcome.

# 2020 Budget and 2020-2024 CIP Approved





The 2020 budget was approved by the Fairway City Council on August 12, 2019. The budget funds all departments as well as various special funds for specific uses. In addition to our routine mill and overlay projects, the 2020 Budget also includes money to assess stormwater infrastructure, the purchase of two new police vehicles and make repairs to the swimming pool liner.

The 2020 Capital Improvement Plan (CIP) includes “Priority 1 Projects” totaling \$564,442 which include:



- ⇒ Street Maintenance:
  - Fairway Road, Cherokee Dr. Eastvale, Neosho
- ⇒ Public Works Department mower
- ⇒ Police Department vehicle replacements
- ⇒ Sidewalk replacement:
  - South side of Shawnee Mission Parkway from Brookridge to Falmouth
- ⇒ Swimming Pool liner repairs



The City uses a **modified, zero-based budget process**. This process requires each Department to identify annually the services and functions it performs; justify the services and functions at the Department level, Committee level, and Finance Committee level; and then build a budget for each line item, starting at zero. This method allows for a detailed look at both the services that are provided and their efficiency. This comprehensive, labor-intensive process requires each committee to review every activity based on its own *merit* as opposed to a budget process that determines funding based only on *previous cost* history.

Hi all,

As fall settles in I wanted to thank everyone for your continued support of our department and of law enforcement in general. We truly appreciate all the kind words, cards and all the other ways you have taken your time to show appreciation to our officers. We work hard to serve everyone in and around our community as best we can, and I want to thank you for taking the time to share your thoughts and gratitude with us.

Over the last 12 months the police department has seen some changes both in staff and in equipment. We have three new full-time officers and one new part-time officer working with us. # Have You Inspected Your Trees Lately?

While mature healthy trees add value to a property, it is important to inspect them in order to protect your home, neighboring homes and utility lines. Take a few minutes to step outside and take a good look at the trees on your property. If you see something that causes you concern, you should have your tree inspected immediately and address any hazards. Otherwise, trees should be inspected every three years or as recommended by a Certified Arborist. Also, consider having your trees inspected after a severe storm, particularly if you have heard cracking sounds or see broken or dangling branches.

## Preventative Tree Care May Help Reduce the Likelihood of Power Outages!

**Trees on Private Property** – Inspect your trees and remove any dead, dying, or questionable limbs. Per KCP&L, vegetation impacting the line that runs from a pole to your meter is your responsibility. If you need to have your powerline dropped for you or your contractor to trim the trees, call KCP&L Vegetation Management 816-471-5275.

**Trees Near Main Powerlines** – If you see a potential issue with vegetation on the lines that run from pole to pole near your house, contact KCP&L Vegetation Management 816-471-5275. KCP&L will send a crew member to review the vegetation's proximity to the power line and trim if appropriate.



## Do You Have Protected Trees in Your Front Yard?

The City of Fairway invests significantly in the protection and maintenance of right-of-way (ROW), park and greenspace trees. Generally, the ROW trees are often thought of as the street trees when you're walking or driving down the street. The ROW on most streets is 25 foot from the center of the road which is about 11 feet behind the curb. If you have trees located within this area, then you have protected trees as ALL trees located in the ROW are considered protected trees. ROW trees may not be trimmed or removed without permission from the Community Tree Manager. The ROW Trees are on a three year trimming cycle where each year a third of the City's ROW Trees are visually inspected by an arborist and trimmed as needed.

Any work done in the ROW can only be done after obtaining a ROW permit from City Hall. Following the proper procedure will save you time and money! When you obtain your permit, you will be given specific instructions on how to protect your ROW tree. You've probably seen the orange snow fence around ROW trees before and this is only part of the protection process.



If you violate the tree protection ordinance you will pay a penalty of \$100 per diameter inch at breast height. This means if you have an 18-inch diameter tree and you or your contractor violate the ordinance, your fine will be \$1,800.00.



**Bottom line? If you are thinking about doing any work (or having someone else do it for you) in the ROW, especially around the trees, contact Public Works 913-722-2822.**



# How Does Storm Damage Brush Collection Work?



Following a significant weather event, staff will conduct an assessment of tree damage throughout the City and consult with the City Administrator and Mayor to determine if the City will activate the Citywide Storm Damage Brush Collection program. In making that decision, several factors are considered with severity and volume of Citywide damage ranking as the two greatest determinants.

The City will communicate via the City Email Program within two business days of an event if the Citywide Storm Damage Brush Collection service is initiated. Once initiated, the City will send updates of progress and current timeline of the pickup via email.

⇒ If the Citywide Storm Damage Brush Collection program **IS** activated:

- ◆ Staff will only pick up limbs from storm damage. Other yard waste must be set out and follow WCA yard waste collection guidelines for regular Monday service.
- ◆ Limbs must be placed in neat piles parallel to the curb. **Not** in the street.
- ◆ Limbs must be cut to sizes no greater than 8' to fit in City trucks.



⇒ If the Citywide Storm Damage Brush Collection is **NOT** activated, homeowners are responsible for cutting and bundling the limbs for WCA's weekly yard waste collection on Mondays. WCA will pickup limbs provided they meet their requirements:

- ◆ Limbs must be less than 2 inches in diameter
- ◆ Limbs must be tied with string or twine in bundles and not exceed 4 feet long and 18 inches in diameter
- ◆ Bundles must weigh less than 40 pounds.

- ◆ Homeowners are responsible for removal of any limbs that do not meet the WCA collection guidelines and may need to contract with a private company.



**City Right of Way Trees:** If a significant sized limb (5" in diameter or greater) has fallen from a City right-of-way tree or has broken and is still hanging in the tree, please contact Public Works 913-722-2822 as they will arrange for its removal.

## How to Sign-up for the City E-mail Program



Simply scan or visit <http://bit.ly/fairway-email>. The quick registration process includes a list of "interests" to choose from. This allows you to select the information you would like to receive. The e-mail program is utilized to disseminate relevant City information in a timely, cost effective manner. Upcoming meetings, crime alerts, street closures, activation and updates of storm damage collection, and special event announcements are just a few examples of the information communicated via e-mail.

**Administration Committee** makes recommendations to the Governing Body on issues pertaining to the Administration Department including: human resources, city policies and guidelines, insurance, and various matters.

**Finance Committee** makes recommendations to the Governing Body on issues pertaining to the finances of the City including: budget, investments, cash flow and debt management.

**Public Works Committee** makes recommendations to the Governing Body on issues pertaining to the Public Works Department including: capital improvements and vehicle and equipment maintenance.

**Police Committee** makes recommendations to the Governing Body on issues pertaining to the Police Department and public safety.

**Parks and Recreation Committee** makes recommendations to the Governing Body on issues pertaining to the City of Fairway Park, swimming pool and Parks and Recreation Department programming.

**Tree Board** develops and reviews annually the written plan for the care, replacement, maintenance and removal of Street and Park Trees and, when requested by the City Council, shall consider any special matter within the scope of its work.

**Planning Commission** is responsible for review of the comprehensive plan, making recommendations on plat approval, subdivision regulations, site plans, zoning regulations, and rezonings. The Planning Commission meetings are held on the last Monday of each month at 6:00 p.m..

**Board of Zoning Appeals** hears appeals of the zoning regulations, grants exceptions and variances to the zoning regulations on the basis and acts as an Appeal Board for appeals of decisions by administrative official in the enforcement of building codes or property maintenance regulations. The Board of Zoning Appeals meetings are held on an as needed

- Continue the strong fiscal responsibilities and practices of the City of Fairway, along with an emphasis on future needs of our citizens.

## 2019 CURBSIDE LEAF REMOVAL PROGRAM


The City of Fairway has arranged for Benjamin Lawn & Landscape to offer a group rate for residential curbside leaf removal for the fall of 2019. Recognizing that some residents may not be able to utilize the service for a variety of reasons, this is a **voluntary program**. For curbside leaf removal on these specified dates, the cost is \$40 for pick-up #1 only, \$52 for pick-up #2 only OR, \$75 for both.

**Step 1:** See the Collection Calendar for when Benjamin Lawn & Landscape will be in your Ward doing curbside leaf removal on dates noted

**Step 2: Review the guidelines.** For a successful curbside leaf pick-up, please remember the following:

- Benjamin Lawn & Landscape trucks are equipped with a side mount vacuum designed to vacuum a long row of leaves. Rake leaves into a pile along the curb (edge of the lawn) that is as long and narrow as possible. The machines can reach 6 feet into the yard so leaves beyond 6 feet may not be removed.
- Leaves are to be raked up to the edge of the lawn as noted above. **DO NOT** rake leaves into the street or gutter and **DO NOT** block the sidewalk.
- Leaves only. Remove sticks, rocks, trash, and other debris.
- Do not block the leaf row with vehicles on collection day.
